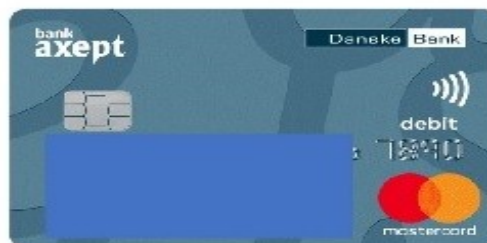


## Facility of Swipe Machine at Embassy of India, Oslo
